An indefinite amount of raffle tickets will be sold. Chennault Museum Board of Directors, Staff, Employees, and volunteers are not eligible to purchase Raffle tickets, nor Management and employees of Interstate Dodge.

- 4. All valid ticket purchases are final and non-refundable.
- 5. Entrant will retain the original printed Raffle ticket. The original printed Raffle ticket stub will be retained by Chennault Museum for entry into the drawing and will be retained thereafter by Chennault Museum pursuant to the charitable gaming laws..
- 6 All unsold tickets and proceeds from the Raffle ticket sales must be received by Chennault Museum no later than 12:00 Noon Central Time Wednesday, July 4, 2018. If received after the official deadline, all associated monies will be returned to Entrant(s) and all associated tickets will be invalid. Additional tickets may be purchased with cash or credit card at Chennault Museum until 12:00 Noon on the drawing date, July 4, 2018.

Chennault Museum will take the necessary steps to insure that each ticket timely purchased has a chance to be selected as the prize winner, and the winner of the Raffle will be determined by random drawing. The drawing will take place on Wednesday, July 4, 2017 at approximately 1:00 p.m. Central Time at Chennault Museum, 701 Kansas Lane, Monroe, Louisiana, 71203. - 8. Entrant(s) do not need to be present to win.
- 9. Winners agree to comply with all IRS and State taxing regulations regarding Raffle winnings. Winner(s) agree to furnish Chennault Museum with his/her social security number, verify his/her identity, and sign all required IRS documents (IRS Form 1099) before claiming prize.
